It is my ethical obligation, as a volunteer with Exodus Housing; to regard all shared information as a sacred trust, which builds a bridge of respect and intimacy.

I understand that the only exception to holding this confidentiality would occur if the potential harm to a child or others exists. In this case, I agree to discuss the situation with the Exodus Housing director or case manager.

I agree that I will always hold all confidential information as a trust and will not discuss it with an unauthorized person. Records entrusted to me will not be shown to anyone outside the authorized group, and under no circumstances will a record be given to any unauthorized person.
